# **Specialized educational programs**

Media Literacy and Media Advocacy for Social Work: Turning the Lens on Social Justice, 2023 This teaching resource is designed to prepare students to inform about issues, teaching them to access, critically evaluate and create media that counter misconceptions and more effectively inform and influence policy. The exercises can be used to help students join the public conversation about the issues they care about, and advocate for social change efforts via social media and popular news outlets.

Media Advocacy and the UN Sustainable Development Goals: Living & Leading in a Global World, 2023 Successfully piloted University at Buffalo's new First Year Global Experience, a program designed to attract under-represented students to study abroad. Led a group of twelve students on a study abroad to Costa Rica, with lectures focused on UN Sustainable Development Goals, human rights, and media advocacy.

Peer Support and Mutual Aid Field Placement: An Innovative Response to the COVID-19 Pandemic, 2020 With many students feeling the effects of the current crisis, a field unit focused on peer support and mutual aid was developed. Placement included participation in a training by Dr. Larry Shulman, former Dean and Emeritus Faculty of UB SSW, on The Dynamics and Skills of Leading On-Line Mutual Aid Support Groups for Peers. Participating students were then deployed to provide online support. Provided ongoing training and supervision for students.

Conversations About Culture: Video and Lesson Plan on Cultural Humility, 2017
This module introduces the concept of cultural humility as a guiding principle for effective cross-cultural communication and collaboration, and can be used as a resource for educators, students planning to study abroad or engage in international fieldwork, faculty engaged in cross-cultural research and partnerships, human service practitioners, educators, and any other interested parties.
